

Data of the legal entity or natural person – entrepreneur shall be incorporated into Unified State Register by writing an entry on the grounds of information from the proper registration cards and data to be rendered by legal entities to the State Registrar according to location of registration case pursuant to laws of Ukraine.

The following data with regard to the legal entity shall be contained in the Unified State Register.

- full name of the legal entity and abbreviated name if available;
- Identification Code of the legal entity;
- Organization and legal form;
- Central or Local Authority of the Executive Council which sphere of management covers State Enterprise or share of the state in the authorized fund of the legal entity if this share is not less than 25 percent;
- Location of the legal entity;
- List of founders (members) of the legal entity including name, place of residence, IN of the natural person – tax payer if the founder is the natural person; name, place of location and IC if the founder is the legal entity;
- Kinds of activity;
- Surname, name, patronymic and IN of the natural person – tax payer who are elected (appointed) to the Board of the legal entity have been authorized to act on behalf of the legal entity without power of attorney including sign the contracts;
- Data of availability of limitations with regard to representation on behalf of the legal entity;
- Data of the rate of the authorized fund (authorized or joint capital) including share of each founder (member) and also rate of the paid statutory fund (authorized or joint capital) on the date of state registration and date of termination of its formation;
- Date and number of entry of state registration of the legal entity, date and number of entry of changes in it;
- Reasons for cancellation of the state registration;
- Series and number of the Certificate of state registration, date of issue or changes in the Certificate of state registration;
- Data of constituent documents, dates and numbers of entries of changes in them;
- Reasons for cancellation of the state registration of changes in the constituent documents;
- Date and number of entry of cancellation of the state registration of changes in the constituent documents of the legal entity;
- Data of record keeping and striking off the register at the Statistics Department, State Tax Department, Pension Fund of Ukraine and Social Insurance Funds;
- Data of the separate units of the legal entities;

- Data of the legal entity being under liquidation particularly date of registration of the founders' (members') decision or resolution of authorities empowered by them concerning liquidation of the legal entity, data of the Liquidation Committee (liquidator, Liquidation Committee etc.);
- Date of approval of interim deed or distribution balance;
- Data of the legal entity which legal successor is the legal entity registered;
- Data of the legal entity – legal successors;
- Date of passing, date of coming into force and number of the court resolution with regard to liquidation of the legal entity what does not connect with bankruptcy, concerning commencement (termination) of bankruptcy case prosecution, bankruptcy declaration and annulment of the state registration of liquidation;
- Date and number of entry of the state registration of liquidation of the legal entity and grounds for recording;
- Date and number of entry of annulment of the state registration of liquidation of the legal entity and grounds for recording;
- Place of state registration and also place of other registration actions prescribed by this Law;
- Whereabouts of registration case;
- Data of issuance of records, extracts and references from the Unified State Register;
- Surname, name and patronymic of an authority wrote an entry to the Unified State Register about state registration of the legal entity, made changes in this entry or recorded the state registration of liquidation of the legal entity;
- Date of passing the registration case to the State Record Office, address of its location;
- Data received in view of mutual information interchange from Department Registers, Statistics Department, State Tax Department, Pensions Funds of Ukraine and Social Insurance Funds: dates and numbers of entry of record keeping at Department Registers, Statistics Department, State Tax Department, Pensions Funds of Ukraine and Social Insurance Funds; dates and numbers of entry of striking off the register at Department Registers, Statistics Department, State Tax Department, Pensions Funds of Ukraine and Social Insurance Funds, data of kinds of the activity including about principal activity category;
- Other additional information of relationship with the legal entity;
- Financial statement of economic activity of the legal entity (except for budget institutions) being composed of a balance and report of annual financial results.

The following data with regard to the state authorities and bodies of local self-government as the legal entities shall be in the Unified State Register:

- Full name of legal entity and abbreviated name if available;
- Identification Code of the legal entity;

- Location of the legal entity;
- Data of an order document on the grounds of which the legal entity was established;
- Date of legal entity establishment;
- Date of state registration of the legal entity;
- Data of the separate units of the legal entity;
- Data of the legal entity being under liquidation;
- Date and number of entry of state registration of liquidation of the legal entity and reasons for recording;
- Date of passing the registration case to the State Record Office, address of its location;

The following data with regard to the natural person – entrepreneur shall be in the Unified State Register:

- name of the natural person – entrepreneur;
- IN of the natural person – tax payer or number and series of the Passport (for natural persons who because their religion or other beliefs refuse from IN and officially notified state authorities of it and have a note in the Passport);
- Place of residence;
- Kinds of activity;
- Date and number of the state registration of the natural person – entrepreneur, dates and numbers of entries of changes in it;
- Reasons for cancellation of the state registration;
- Series and number of Certificates of state registration, date of issue or change of the Certificate of state registration;
- Reasons for cancellation of the state registration of changes in data of the natural person – entrepreneur;
- Data of the date of record keeping and striking off the record at Statistics Department, State Tax Department, Pensions Funds of Ukraine and Social Insurance Funds;
- Data of the natural person – entrepreneur being under liquidation of business activity particularly date of passing, date of coming into force and number of the court resolution with regard to liquidation of the legal entity what does not connect with bankruptcy, concerning commencement (termination) of bankruptcy case prosecution, bankruptcy declaration and annulment of the state registration of liquidation;
- Surname, name and patronymic, IN of the natural person – tax payer appointed as the natural person – entrepreneur’s property manager;
- Date and number of entry of state registration of liquidation of business activity by the natural person – entrepreneur and also reason for recording;
- Date and number of entry of cancellation of the state registration of liquidation of business activity of the natural person – entrepreneur and also reasons for recording;

- Place of state registration and also place of registration actions prescribed by this Law;
- Whereabouts of the registration case;
- Surname, name and patronymic of a functionary wrote entry of the state registration of the natural person – entrepreneur, made changes in this entry or wrote entry of state registration of liquidation of business activity by the natural person – entrepreneur;
- Data received in view of mutual information interchange from Department Registers, Statistics Department, State Tax Department, Pensions Funds of Ukraine and Social Insurance Funds: dates and numbers of entry of record keeping at Department Registers, Statistics Department, State Tax Department, Pensions Funds of Ukraine and Social Insurance Funds; dates and numbers of entry of striking off the register at Department Registers, Statistics Department, State Tax Department, Pensions Funds of Ukraine and Social Insurance Funds, data of kinds of the activity including about principal activity category;
- Other additional information of relationship with the natural person – entrepreneur.

Data of absence of the legal entity at the place of location and absence of confirmation of data of the legal entity and also data of the reserved name of the legal entity shall be contained in the Unified State Register.
